### PARK RULES

Park hours are from dawn – dusk

Dogs must be on a leash until they enter park.

Dogs must remain within sight of their handler at all times.

Handlers must have one leash per dog.

All dogs must be licensed and handler must have park use tag on their person.

Dogs must be leashed at the first sign of aggression or unruliness.

If your dog is not neutered or spayed, enter at own risk.

No more than 2 dogs per handler are permitted

Handlers must clean up after their dog (s) in the park area.

Handlers must observe all other applicable ordinances, rules and regulations.

Dogs declared dangerous animals under city code, section 6-102, or dangerous or potentially dangerous dogs under State Statutes are not allowed in the park area.

## **Tips For Enjoying The Dog Park**

Bring ample water for your dog (s)

Do not bring food or toys into the area. They may create a conflict.

Do not bring glass containers into the area.

Vaccinate dogs by the recommendation of your veterinarian.

Extend common courtesy to all other user.

No bare feet, footwear is required
