Terms of Use:

Food and drink are **not allowed** in the pool area or the locker room. Renter may bring cake, pizza, other small snacks and drink for their party and set up in the pool lobby area. No other food is allowed for pool rental. Only (1) table and 10 chairs are provided for lobby area, renter must supply any utensils, plates, etc. needed for lobby.

Any time a school or City activity needs the use of the pool, and the pool has been rented, the school and City activity will take priority over a pool rental agreement. All fees would then be refunded for the rental or the rental activity rescheduled. **Fees must be paid in full in order to reserve the pool.**

I understand that Portage Park and Recreation programs and activities involve risk of serious bodily injury, including disability of death, and loss or damage to my property. Athletic and pool activities present risks to participants. Despite the variety of risks that may be present, I hereby release and waive any liability claim against the City of Portage, its employees, its agents, and the Portage Community School District, with respect to any and all claims for injury, disability, death, or loss or other damages based on negligence, related to my, or my child's, participation in the Portage Park and Recreation Department programs and activities at the Portage Community Pool.

I understand that I may bargain for a different waiver of liability terms. However, I hereby waive my right to bargain for different waiver of liability terms. I have read this Release and Waiver of Liability and understand its terms. I know that I am giving up substantial rights by signing it, but I do sign it freely and voluntarily.

Terms of Use

- Renter may not enter to begin party until time of rental. (Meaning a party from 4 pm to 6 pm does not enter lobby until 4 pm.)
- Party must exit facility by the end of rental period. Guards will ask party to exit water a minimum of 15 minutes before contracted end of time.
- Cleanup of lobby is the responsibility of the Renter. Guard or Attendant may assist, but messes not cleaned up by Renter are subject to additional costs.
- A two hour rental does not equate to two hours of swim time. Entry, exit, snack time or any other activities planned for your party will all count against the two hour rental.
- No floatation devices allowed in the pool. Arm floaties and pool noodles are allowed but must be brought by the Renter.
